

3rd Annual Jack Byrne Short Track Speedskating Championships
Sponsored by Syracuse SSC at Sunnycrest Ice Rink, Syracuse, NY
Saturday, January 15, 2011

This meet is sanctioned by U. S. Speed Skating through the Northern New York Skating Association

Eligibility:

- All skaters must be registered speed skaters of the United States or Canada.

Check-In: Sunnycrest Ice Rink, 8:30-10:00 am [race day emergency phone: (315) 350-0209]

Racing: Begins at 11 AM. Warm-up 10 AM to 10:40 AM, starting with younger skaters and working up through adults. 4- 10 minute groups. We plan on finishing meet by 7 PM.

Awards: 1st through 6th overall in each group. Skaters must skate in all events to be eligible.

Planned Events: The meet will be “old” single meet format for all skaters. Skaters will be divided into groups based on ability using the 500m or 333m time submitted. Three events are scheduled for each group. Each event is scheduled to include a heat and a final. Time skated in a heat is used to place the skater in the primary, secondary, or tertiary final. The events (distances) will be suitable for the ages and skills of the skaters based on the group assignment. Time permitting, an unofficial relay race will be offered. “Tiny tot” group (under 6 yr.) will skate just 3 races early in the competition.

ENTRY FEE & DEADLINE:

- US \$30.00 per skater (\$60.00 max. per family)
- “Tiny tot” fee US \$15.00 per skater
- All skaters will be assessed a \$10 deposit at check-in for a required helmet cover; deposit will be refunded upon turning-in the helmet cover at the conclusion of the meet. Exact change is requested.
- Entry Form & payment must be received by SSSC by Tuesday, January 6. Skaters not registered and paid by January 6 will be assessed a US \$25 late fee and acceptance into the meet will be at the Meet Director’s discretion and subject to space availability in the scheduled heats.
- Entries may be e-mailed to Treasurer@Syracusespeedskating.org . Payment must still be mailed and received by January 6, 2011 or entry will be deemed late.

REQUIREMENTS: Helmet (US Speedskating requirement), gloves, long sleeves, knee pads, neck protection and shin guards. Safety glasses meeting ANSI standard Z 87 and helmet meeting ASTM F1849 are highly recommended.

From East via NYS Thruway (I-90): Exit 34a to 481 South to 690 West. Exit 690 East at Teall Ave. Turn right at end of exit ramp. Go up the hill. Turn right at next traffic light at the top of the hill onto Robinson St. Rink is at end of street behind Henninger High School.

From West via NYS Thruway (I-90): Exit 39 to 690 East. Exit 690 East at Teall Ave. Turn left at light at end of exit ramp. Go under the bridge and up the hill. Turn right at next traffic light at the top of the hill onto Robinson St. Rink is at end of street behind Henninger High School.

From North or South via I-81: Exit I-81 South onto 690 East. Exit 690 East at Teall Ave. Turn left at light at end of exit ramp. Go under bridge and up the hill. Turn right at next traffic light at the top of the hill onto Robinson St. Rink is at end of street behind Henninger High School.
